### RULES AND REGULATIONS

- a) Open to all Malaysians.
- b) A maximum of TEN (10) entries for the competition. Entry fee is RM10.00 per entry.
- c) Colour print submitted and printed on 12R size (12" x 18"). Each entry must be accompanied with CD ROM having digital copy of the same photo in JPEG file format together with the entry form listing your name, contact information and entry fee.
- d) The images submitted **SHALL**:-
  - i) relate to the theme "**Colours of Our City**"
  - ii) include architectural features
  - iii) be taken in Sabah and Labuan onlyEntrants may provide short write up describing the images taken (Optional with max 50 words in English or Malay language).
- f) All images submitted must be the work of the individual submitting them. It is the responsibility of each entrant to ensure that any images they submit have been taken with the permission of the subject and do not infringe the copyright of any laws. Participant must warrant that the photography they are submitting is their own work and that they own copyright for it.
- g) The organizing committee reserves the right to amend, delete or add to the above Rules and Regulations at any time without prior notice.
- h) Photographs submitted are **NOT** returnable and all entries shall remain the property of the organizer. The organizer reserves the rights to reproduce publicize or exhibit them without notification or payment to the photographers.
- i) The decision of the judge is final and **NO** queries on the result will be entertained.
- j) All information describing how to enter this competition forms part of these Rules and Regulations. It is a condition of entry that all Rules are accepted as final and that the participant agrees to abide by these Rules.
